GLaM provides a **flexible and personalized curriculum**, along with the possibility of taking advantage of opportunities organized with foreign universities. The course offering is enriched by research and training experiences (internships, apprenticeships) with the **involvement of companies**, **institutions** and **public and private organizations** with a view to being competitive in the job market.

- At least a Bachelor's degree from an internationally recognized institution at the university level including the equivalent of at least 27 ECTS credits from the academic area of law or legal studies
- Good knowledge of the English language with at least a B2 level according to the European Common Framework
- A personal background with suitable professional, vocational and academic experience appropriate to the nature of the degree course

- Coherence between applicant's previous studies and the academic objectives of the Master's degree program
- Academic curriculum
- English language competence
