#### Art. 1 – SUBJECT OF THE CALL

The University of Trento announces the 41st cycle of the Doctoral Programme in Psychology and Cognitive Science for the 2025/2026 academic year.

Application deadline: May 26, 2025, 4:00PM (Italian time)

Positions: n. 11 Scholarships: n. 11

**Supernumerary positions:** n. 1 (available for candidates who fulfil the requirements set out in art. 8).

The grants (three years) are financed as follows:

- n. 6 grants financed by the University of Trento;
- n. 2 grants financed by Fondazione Bruno Kessler on the following topics:
  - Fairness and bias in generative NLP;
  - Artificial Intelligence for education and self-improvement;
- n. 1 grant financed within the Project of Excellence Law 232/2016, Department of Psychology and Cognitive Science of the University of Trento – CUP E73C23000020001;
- n. 1 grant financed by the Department of Psychology and Cognitive Science within the Project "VIPPSTAR Visually Impaired children and adolescents: bridging the gap with Personalized Prevention Strategies, Tools, Approaches, and Resources" (CUP E73C240006100006) on the following topic:
  - "Enhancing the Psychophysical Well-being of Visually Impaired Preadolescents and Adolescents through Technology-Mediated Rehabilitation and Psychoeducational Interventions";
- n. 1 grant co-financed by Unione Buddhista Italiana U.B.I. on the following topic:
  - "Non-Dual Consciousness and Meditation: Neuroscientific and Technological Approaches".

Furthermore, candidates selected by dedicated committees are also eligible for the 41st cycle, as they are involved in specific international mobility programs in which the University of Trento participates.

Topic-specific grants are conditional to the execution of a particular research topic for which specific skills are required. Those interested in these grants should carefully check the topic and required skillset indicated on the web page phd.unitn.it/drsc/en/node/182.

The number of places covered by scholarships and/or by internship contracts and by other potential financial support may be increased by funds from other universities, public research bodies or prestigious private companies, that become available after the publication of this announcement and before the evaluation of qualifications. Such occurrence will be communicated online, and nowhere else, at this <u>selection's webpage</u>.

#### **IMPORTANT**

The results of the selection (qualifications assessment and interview) will be published at the <u>selection's webpage</u>, together with the list of applicants (using their application ID) that are not admitted to the selection after a formal check or after the evaluation of the foreign qualification.

No personal correspondence will be sent to excluded candidates, the online ranking list will be the only official information.

Notwithstanding the provisions of the following articles 5 co. 8 and 6 co. 5 of this selection announcement, any notifications relating to the application will be emailed to the address linked to the account registered upon application. Candidates who are still enrolled



or have recently graduated from the University of Trento are advised to check that their email address is valid at this link: Profile data. Any changes to personal contact details after the application is closed should be communicated to the PhD Office - Cognitive, Social Sciences and Humanities (phd.office-cssh@unitn.it).

#### Art. 2 – ADMISSION REQUIREMENTS

- 1. Applications for admission to the selection process are accepted from candidates regardless of gender, age and nationality, who hold:
  - a) an Italian "Laurea Specialistica or Magistrale" (Master's Degree) according to Ministerial Decree no. 270 of 22 October 2004, or a university degree awarded under the previous Italian regulations;
  - b) or a second level degree awarded by an Italian "AFAM" Institute (Artistic and Musical Higher Education);
  - c) or an equivalent degree qualification obtained abroad (Master's Degree) at a recognized academic Institution, which:
    - allows access to an equivalent PhD course in the country/higher education system of origin (unless substantial differences are encountered);
    - is equivalent to the Italian Laurea Magistrale (Master's Degree), in terms of duration, level and subject area1;
    - is considered suitable<sup>2</sup> by the Admission Committee for the sole purpose of admission to the PhD Programme.
- Applications are also accepted from candidates who do not hold the required degree but expect to obtain it, by 31 October 2025.
   In this cases admission is "conditional" and applicants must submit the degree certificate or a self-declaration to the PhD Office Cognitive, Social Sciences and Humanities (email: <a href="mailto:phd.office-cssh@unitn.it">phd.office-cssh@unitn.it</a>) no later than November 7, 2025. Failure to provide the certificate will lead to exclusion.
- 3. It's in the applicant's best interest to provide all elements necessary for evaluation, especially in case the educational system of the country where the title was obtained is not comparable with the Italian one.
  - The Evaluation Committee reserves the right to ask applicants to provide additional documentation, if deemed necessary, in order to be considered for the selection.
- 4. Candidates who have already obtained a PhD degree can apply for a second PhD Programme only if its main research topics and scientific-disciplinary fields are different from those of the candidate's first Doctoral Programme. For applicants who have already benefited even partially from a doctoral scholarship in the past, the admission to the new PhD Programme can't be covered by a scholarship<sup>3</sup>.
- 5. The list of candidates' IDs whose academic degree has been considered not eligible for the admission selection by the Evaluation Committee will be available at the <u>selection's webpage</u>.

#### Art. 3 – THE DOCTORATE PROGRAMME

1. The Programme is shown on the web page of the doctoral course <a href="mailto:phd.unitn.it/drsc/en/node/184">phd.unitn.it/drsc/en/node/184</a>.

IMPORTANT: In the second year, all enrolled PhD students are required to spend a study period of research abroad for a minimum of six months.

#### Art. 4 - APPLICATION

- 1. The application must be completed and submitted by **May 26**, **2025 4:00 p.m.** (**Italian time**), exclusively through the online system: https://www.unitn.it/en/apply/dott which will be available within three working days from the date of publication of the notice.
- 2. Applicants can access the online registration procedure in one of the following ways4:
  - with a SPID account or CIE (Elecronic Identity Card): those who have an Italian Tax Code (codice fiscale) and an Italian identity document must access the registration with CIE (more information at <a href="https://www.cartaidentita.interno.gov.it/en/home/">https://www.cartaidentita.interno.gov.it/en/home/</a>) or with SPID, the Italian Public Digital Identity System, which automatically certifies the identity of the person on the UniTrento systems and sets up an @unitn.it account.

  - with a UniTrento account: those who already have an account issued by the University can access the registration procedure

  - registration of UniTrento "guest" account: anyone who does not have an Italian Tax Code can register a temporary account as a "guest". After enrollment, this account will be converted into a definitive@unitn.it account.

- 3. Participation in the selection process is subject to the payment of a non-reimbursable application fee of €30.00 by pagoPa system<sup>5</sup>, as indicated in the appropriate section of the application ('Selection participation fee').
- 4. Administration highly recommends that candidates make sure to have received the notification email confirming that their application has been successfully completed and submitted.
  - UNiTrento refuses any responsibility for all those applications not properly closed by candidates.
- 5. Candidates will be considered totally responsible of their applications. Incomplete or irregular applications, missing attachments, non-payment of the participation fee, or applications transmitted in ways other than those set out in this article, shall not be considered valid and candidates will consequently be excluded from the selection process.
- 6. All applicants are admitted to the selection **conditionally upon ascertaining that they fulfil the admission requirements**. The University of Trento has the right to verify the documents delivered pursuant to articles 71 et seq. of the Presidential Decree n. 445 of the 28.12.2000.
- 7. A candidate whose submitted degree does not satisfy the requirements specified in art. 2 or if the information provided in the application is not true, may be excluded at any time from the selection process or even after enrolment and the beginning of the PhD course.
- 8. According to Italian Law n. 104/92, Art. 20 and to Italian Law n. 68/99, Art. 16 (1), applicants with special needs or with learning disabilities, according to their particular disability may explicitly request special assistance or extra time during the examinations in their online application. In this regard, the data will be processed in compliance with the regulations in force as indicated in the information on the processing of personal data (art. 10 of this call).
- 9. The application is to be considered for all purposes in law as a self-certification of personal data and declared qualifications.
- 10. COMPULSORY ATTACHMENTS (failure to upload one or more compulsory attachments results in expulsion from the selection)6:
  - A. Identity document (ID):
    - a copy of the **identity card** (for EU citizens) **or** of the **passport** (pages with photo, personal data, place and time of issue of the document, expiration date of the document);
  - B. Documents related to the academic degree:
    - a. Italian qualification

- already obtained/to be obtained: a self-declaration, in accordance with the Presidential Decree Article 46 n. 445 of 28.12.2000 and subsequent amendments, stating:
  - the possession / not possession of the degree (see Art. 2),
  - type of degree / degree to be obtained,
  - "Classe di laurea",
  - award date and final grade / possible award date,
  - issuing University,
  - list of examinations taken, date of successful passing, credits and grades obtained. A fac-simile is available for download on the selection webpage, but similar documents are also accepted as long as they contain the information required in the call. Graduates from the University of Trento may only declare the place and the date of award / foreseen date of award as the other information can be collected ex officio.

Italian degree applicants who have not yet obtained their degree, who expect to complete it by October 31, 2025 and therefore "conditionally" admitted to the selection, need also to provide a statement from the thesis supervisor or other academic/administrative supervisor/staff declaring that conferral of the University degree will occur by October 31, 2025.

#### b. Foreign qualification

- already obtained:
  - a certificate attesting to the possession of a second level university qualification (see art. 2 paragraph 1 letter
    c), issued by the institution that awarded it. The certificate must indicate the type of diploma, the date it was awarded
    and the relative grade;
  - the list of examinations taken to obtain the qualification to access a Doctoral Programme (academic transcript of records of the Master's degree) with relative credits (if provided for in the university system of the country that awarded the qualification), marks, and rating scale. If the university studies carried out abroad are divided into first and second level, the Bachelor's degree and the list of examinations taken to obtain that degree (academic transcript of records of the Bachelor's degree) should also be attached.

If the foreign academic qualification has already been recognized as equivalent<sup>7</sup> to a second cycle Italian qualification **by the competent academic bodies of Italian universities**, the equivalence provision (Rectoral Decree) must be attached in the appropriate section of the online application.

- to be obtained (the following two points refer to foreign degree applicants who have not yet obtained their degree, who expect to complete it by October 31, 2025 and are therefore "conditionally" admitted to the selection):
  - a **certificate of enrolment in a course of study that allows admission to a Doctoral Programme** (see art. 2 paragraph 1 letter c), with a **list of the examinations** successfully passed, credits obtained in each examination (if provided for in the university system of the country that awarded the qualification), marks, rating scale (academic transcript of records) and the possible award date. If the university studies carried out abroad are divided into first and second level, the Bachelor's degree and the list of examinations taken to obtain that degree (academic transcript of records of the Bachelor's degree) should also be attached.
  - a letter signed by the thesis supervisor or other academic/administrative supervisor/staff stating that the candidate will obtain the academic title by October 31, 2025.

If the aforementioned documents are different from Italian or English, they must be accompanied by a translation in Italian or in English, made provisionally by the applicant who takes responsibility for the accuracy of the translation and its compliance with the original text, in order to allow the Admission Committee to evaluate the eligibility of the certificate, for the sole purpose of participation participating in this admissions process.

In addition, if available, also the following documents:

- Academic degree (diploma) of the required title (Master of Science/Art or equivalent) in the original language;
- Diploma Supplement<sup>8</sup> (according to the model developed by the European Commission, the Council of Europe and UNESCO / CEPES), or:
- Declaration of value<sup>9</sup> which certifies that the educational qualification is valid in the country of achievement for being admitted to Doctoral Programme (third level of higher education according to the Bologna Process - European Higher Education Area; EQF level 8), or:

- the Statement of comparability university qualification <sup>10</sup> awarded by the ENIC-NARIC Center in Italy (CIMEA) that contains all the information necessary for the evaluation of the qualification.
- **C. Motivation letter** (in Italian or in English) indicating why you chose to join a PhD and in particular the PhD program in Psychology and Cognitive Science;
- D. Curriculum vitae et studiorum (in Italian or in English, preferably using the Europass model) including any research skills obtained by the applicants, any other academic degrees (2nd level Masters, PhD degrees, specializations, other high school education, etc.), or any other document relevant to the topic of the call (list of publications, participation in conferences, etc.);
- E. Research project (only one) in Italian or in English language (approximately 3,000 words, excluding references and abstracts) accompanied by abstract (approximately 150 words) and bibliography. It is to be filled in following the guidelines of the document "schema\_progetto.pdf" available on the <a href="selection's webpage">selection's webpage</a>, related to one of the research areas listed in Art. 3. The project have to be potentially feasible in the Doctoral Course with the supervising of a component of the PhD Committee (please check the areas of interest of teachers at link <a href="phd.unitn.it/drsc/en/node/181">phd.unitn.it/drsc/en/node/181</a> and the topic-specific grants page at phd.unitn.it/drsc/en/node/182).

Only one research proposal per candidate is allowed.

#### 11. OPTIONAL ATTACHMENTS:

- · List of publications;
- summary of the master' thesis (rationale, research methods, results and implications)
- copy of the degree dissertation;
- document reporting any other relevant information about the role, and the skills acquired, during research related experiences;
- certificates (if any) proving the knowledge of the English language;
- any other documents useful to demonstrate the candidates' research skills and their abilities;
- Up to **two** Academic Reference Forms <sup>11</sup> filled out by experts structured as University staff or in national or international research organizations. Within 24 hours of completing and saving the online Referees section, the online application system sends an email directly to Referees chosen by the applicant with the attached form and instructions on filling it out and transmitting it to the University. It is highly recommended that applicants verify that their Referees send the Academic Reference Forms no later than the first step of the selection process begins (see dates and details at the selection's webpage.
- 12. Should candidates wish to add and/or change further documentation to the application after having already submitted the application, they may do so **by the deadline of the selection announcement** emailing <a href="mailto:ateneo@unitn.it">ateneo@unitn.it</a>. In this case, **the subject line should be**: Application ID Candidate's Last Name and Name Doctoral Course in Psychology and Cognitive Science 41th cycle "integrazione domanda", and the body of the email should contain a note explaining the purpose of the additional or changed attached documentation<sup>12</sup>.

Documentation sent by other means will not be accepted.

#### Art. 5 – APPLICANT EVALUATION

- 1. Upon hearing the Doctoral Programme Committee the Rector appoints the Admissions Committee. It consists of at least three members chosen among Italian and foreign professors and researchers, who are experts in the scientific areas of the Doctorate. The Committee may also include up to two experts, even foreign, of public and private national and international research organizations.
- 2. The selection exams are intended to assess the applicant's preparation and aptitude towards scientific research with specific reference to the chosen research topic.
- 3. The selection takes place as follows:
  - evaluation of curriculum vitae, qualifications and research proposal (according to above Art. 4) on the basis of criteria established at the beginning of the selection process by the admissions Committee:
  - an interview intended to assess the research knowledge and the attitude of the candidate to the research in the fields of the research project presented. The selection may be held in Italian or in English language prior authorization by the Admission Committee. In any case, candidates have to demonstrate a good knowledge of English.
- 4. Candidates who intend to compete also for a **topic-specific grant**, indicated in article n.1 of this call, must express their interest in the online application and present a project related to the specific topic; they will be evaluated on the knowledge of the specific subject matter(s) of that grant during the interview.

- 5. Candidates may also opt for topic-specific grants made available after this call's publication. In order to be considered for the additional topic-specific grant/s, the candidates must express their intention to the Admissions Committee before the assessments of qualifications, following the instructions given at the <u>selection's webpage</u> in case of new available scholarships. In such case, their knowledge on the specific topic of the scholarships will be evaluated during the interview.
- 6. The option for a topic-specific grant expressed by a candidate implies the preference of the candidate for the award of that specific scholarship with respect to all others.
- 7. The Admissions Committee has an overall score of 120 points available, partitioned in the following way:
  - 60 points for the qualification's assessment;
  - 60 points for the oral examination.

In order to be admitted to the interview candidates must reach a minimum score of 36/60 in the assessment of qualifications and research project.

- 8. The results of the assessment of the qualifications and of the oral exam will be published at the selection's webpage<sup>13</sup>.
- 9. The candidate may choose to be interviewed in one of the following two ways:
  - a) in presence, at the University of Trento.
     In this case the candidate must show a valid ID document before the interview begins. Should the candidate fail to attend the interview for whatever reason this will be considered as renunciation of participation in the selection procedure;
  - b) by videoconference through the use of audio-video connection tools that allow the correct identification of the participants (through a webcam) and the carrying out of the interview in public.
     The starting time of the interviews are established by the Commission. The candidate must first show the same identity

document attached to the application. Failure to connect or unavailability at the established date and time or failure to show the identification document, will result in exclusion from the selection. The University assumes no responsibility in the event of technical problems that do not guarantee the proper conduct of the interview.

The indication of the date and time and of the place (seat of the University of Trento, if in presence) where the interview will be held will be provided at least 20 days prior to the date of the interview on the selection's webpage.

Any changes in the date of the examination will be published on this same web page.

10. The oral examination is considered passed with a minimum score of 36/60.

#### Art. 6 - RANKING

- 1. The Committee draws up a merit-based ranking according to the scores obtained by the applicants from the qualification's assessment, the project and the interview.
- 2. Scholarships are assigned to eligible candidates based on:
  - a) Ranking order;
  - b) candidate eligibility for topic-specific grants. Please note that topic-specific grants are assigned following the ranking and until their maximum number is filled.
- 3. The candidate who has been awarded a topic-specific grant, must accept it since the choice for a topic-specific grant he/she expressed implies the candidate's preference for the award of that specific scholarship with respect to the others.

  Renouncing the topic-specific grant implies the exclusion of the candidate from the right to enroll in the PhD Programme.
- 4. Unassigned topic-specific grants will result in the reduction of positions available.
- 5. The ranked list (using candidates' application IDs) will be published on the selection's webpage.

By publishing the ranking, notification concerning the selection results is considered fulfilled. Admitted candidates will not receive any personal messages.

#### Art. 7 – ADMISSION TO THE DOCTORAL PROGRAMME AND ACCEPTANCE OF THE OFFER

- 1. Applicants will be admitted to the Doctorate according to their rank in the final score list and until all available and eligible positions have been filled.
- 2. In case of equally ranked candidates, the candidate's economic situation shall be the deciding factor, in accordance with the Decree of the President of the Council of Ministers (D.P.C.M.) of 9 April 2001 as amended.
- 3. If an eligible applicant withdraws before the beginning of the Programme (1st November 2025), the next applicant in the ranking list will be offered the place.
  - This candidate is expected to accept the offer **within 8 days** from the day after having received the notice from the PhD Office Cognitive, Social Sciences and Humanities.
  - If an eligible applicant withdraws or is excluded in the first three-month term of the first year, the Doctoral Programme Committee may decide to fill the vacancy with another candidate next in rank in the final score list.
- 4. Admitted applicants must accept the offer **within 8 days** from the day following the day of publication of the final ranking list by submitting the online application available at https://www.unitn.it/en/study/register/information-phd-students/enrolling-phd.

Admitted applicants with a qualification that has not been awarded in Italy must deliver to the PhD Office Cognitive, Social Sciences and Humanities, in advance by email (PhD.office-cssh@unitn.it) if they had not already done so during the application phase, the following documents by November 7, 2025:
  - original or certified copy of the academic diploma of the Master degree (Master of Science/Arts or equivalent) together with the academic transcript of records, possible official translations<sup>14</sup>, legalized<sup>15</sup> or with an apostille affixed (verify the fulfilment of the requirements set by the issuing country of the title);
  - Diploma Supplement (if provided for by the university where the title was issued, it is commonly used within the member countries of the European Higher Education Area (EHEA))

Declaration of Value issued by the Italian diplomatic or consular representations country of origin of the institution that issued the title

alternatively

Statement of comparability of foreign university qualifications 16 issued by the ENIC-NARIC Center in Italy (CIMEA) that contains all the information necessary for the assessment of the qualification.

In case the Diploma Supplement, or the Declaration of Value, or the Statement of comparability are not available by November 7, 2025, admitted applicants must deliver a document showing that they asked the University/the Italian diplomatic or consular representations/the ENIC-NARIC center for the documents to be issued.

Admission to the Doctoral Programme for successful candidates who do not provide the required above-mentioned documents by November 7, 2025 will be "conditional" and the applicants will be excluded from the Doctoral Programme if:

- they do not deliver the documents within 6 months from the starting date of the Programme;
- upon verification, their title is not in compliance with the requirements of this call for selection.

Forfeiture from the course will result in the obligation to return any monthly scholarship money received.

6. Short-listed applicants who do not submit their acceptance within 8 days from when the final ranking is published lose their right to enroll and their position will be offered to the next ranked eligible candidate.

#### Art. 8 – ENROLMENT

- 1. The official registration in the doctorate, limited to short-listed candidates who have accepted the position according to the procedures in the preceding article, will automatically be made official as soon as the PhD Programmes' requirements verification by the Ministry of Education, University and Research for the 2025-2026 a.y. has been completed.
- 2. In case of no conferrable accreditation, candidates who have accepted the position will receive a timely notification via email and the local education tax (TDS) will be refunded.
- 3. To complete enrolment, the candidate who has obtained the qualification abroad, upon arrival in Italy, will have to show the official documents (in original or copy conforming to the original), related to the academic path, already anticipated in a scanned form during admission to the selection or during the matriculation process, in order to allow the appropriate verification of the validity of the qualifications, also by means of the national information centers on the recognition of foreign titles as part of the ENIC-NARIC network. Until such time, candidates are admitted to the course conditionally and may be excluded if they do not meet these requirements.

#### Art. 9 - INTELLECTUAL PROPERTY RIGHTS OF RESEARCH FINDINGS AND PUBLICATIONS

- 1. Without prejudice to the Italian law on copyright (legislative decree 633/1941 and subsequent amendments), intellectual and industrial property rights on the results eventually achieved by the doctoral student, including (but not limited to) software, industrial inventions patentable or not, know-how, models, data and data collection, are regulated in accordance with applicable laws and University regulations and, if necessary, according to the provisions in the individual agreements with universities, companies or entities involved<sup>17</sup>.
- 2. Before the start of the research activity, the doctoral student is required to sign a specific declaration of commitment to confidentiality in relation to the information, data and documents of a confidential nature that he / she may become aware of in carrying out his / her activity at and / or on behalf of the University. At the same time, each PhD student is required to sign a specific declaration of transfer of intellectual property rights to the University, so that he / she is aware of the application of the relevant legislation and the University Regulations on intellectual property and possibly a confidentiality agreement with the funding body. if required, if the position is funded by an entity external to the University.

### 3. Purpose of the processing and legal basis

The Data joint Controller process personal data as part of the performance of their public interest tasks and, in particular, for the purposes of carrying out this selection procedure and complying with a legal obligation (Art. 6, par. 1, lett. e) and c); Art. 9, par. 2, lett. g) of the GDPR).

#### 4. Nature of the provision of data

The provision of personal data is necessary for participation in this procedure and failure to provide such data will result in the impossibility of taking part. The provision of special health-related data (for candidates with disabilities) is optional, but failure to provide it will result in the impossibility of accessing the requested support tools.

#### 5. Data processing methods
