Research Integrity has gained increasing attention and relevance within the European Union and in the context of research funding, which must comply with the ethical principles established at national, European, and international levels, as well as with the European Code of Conduct for Research Integrity (ALLEA).

What are Research Integrity and Questionable Research Practices?

What are the principles established at UniTrento and the European standards? And what are the consequences in the event of a violation?

How can research be promoted, communicated and published in an ethical and responsible manner at national, European and international levels?

Where are the emerging challenges in this area and how can opportunities for discussion and sharing on these issues be created?

How can a project be developed and submitted to the CER or other relevant ethics committees?

The Office of Research Ethics and Integrity and the INTEGRA group of the University of Trento are promoting this series of meetings with the aim of trying to provide answers to these questions.

Good practices for accessing the University Research Ethics Committee and managing protocols (IN ITALIAN)

date: Tuesday, 30 September 2025, 2 p.m - 4 p.m.

The workshop aims to provide participants with essential information on the procedures required to obtain the opinion of the University Research Ethics Committee (CER). It will also cover the use of process streamlining, as well as the use of the Service Desk and related tools. The theoretical session will be complemented by an in-depth analysis of practical examples, focusing on the main issues that arise when developing research protocols to be submitted to the Committee, based on the experience and support provided by the CER technical secretariat, thus offering participants concrete guidance for effectively preparing and managing their submissions.

Research Integrity in action: principles, cases and tools (IN ENGLISH)

date: Tuesday, 18 November 2025, 2 p.m. - 4 p.m.

The workshop offers a concrete and interactive opportunity to address the issues of Research Integrity through the discussion of practical cases covering all phases of the research process, from idea to publication, including responsible analysis and communication of results, securing funding, use of resources, participant protection, and relationships with supervisors, institutions, and co-authors.

A dedicated session will examine the issues arising from these cases in light of the regulatory framework with particular attention to the rules of the University of Trento, as well as national and European regulations, and the potential consequences of non-compliance.

Generative AI Research Integrity: practical case and new challenges (IN ENGLISH)

date: Thursday, 20 November 2025, 3 p.m. - 5 p.m.

What Challenges does generative artificial intelligence pose in research contexts?
How can it be used in compliance with Research Integrity principles?
Are there relevant regulations and standards?

The workshop aims to analyse these issues, as well as the experiences and questions of the university community, through a practical and interactive approach, including practical cases that will allow participants to discuss the potentials, risks, ethical dilemmas, and legal issues associated with the use of generative AI across all phases of research.

A dedicated session will examine the issues arising from these cases in light of the existing regulatory framework, with particular attention to the University of Trento's guidelines, and the legal and regulatory context at national, European, and international levels.
