Subject to verification of the partner university's availability, the Selection
Committee reserves the right to assign mobility places without a UniTrento
scholarship, but with a potential reduced tuition fee (within the limits and terms
provided by the agreement) at the partner university.
The main objective of the TLP-Transnational Law Program for single-cycle
Master's Degree students and the TGP-Transnational Glam Program for Global
Law Making Master's Degree students is the creation of a transnational legal
education pathway through an integrated teaching path across different faculties.
Starting from August 2026, selected students will attend two semesters for the
LL.M. at WUSTL. The beginning of the first semester will be preceded by an
intensive orientation period.
WUSTL ranks among the top 20 American universities (position n. 14 in the 2024
"Best Law Schools" ranking).
Upon completion of the study path provided by the TLP and TGP programs, the
student will achieve a double degree: a Master's Degree from the University of
Trento and an LL.M. from WUSTL.



Only for 5-year Master's Degree students participating in the TLP program: the LL.M. degree, if obtained according to the methods indicated each year by WUSTL (in particular with reference to the inclusion of specific compulsory courses in the study plan and the achievement of a specific number of credits), will allow—normally after also obtaining the Italian single-cycle degree—to take the Bar Exam for access to the legal profession and, once passed, to practice law in the states of California, New York, and Missouri (for further details, see the web Bar Admission Guide website). To date, the TLP program has been completed by 77 students, 10 of whom have taken the Bar Exam in the State of New York.

The LL.M. degree does not grant access to the Bar Exam to Glam Master's Degree students participating in the TGP program.

# Academic Requirements for Application at UniTrento

### **TLP Program:**

- Enrollment in the second year of the 5-year Master's Degree in Law (fiveyear program);
- Having passed at least five out of the seven fundamental exams planned for the 1st year of the 5-year Master's Degree in Law;
- Acquisition of at least 42 credits (CFU);
- Weighted average grade of at least 26,00/30.

### **TGP Program:**

- Enrollment in the first year of the Master's Degree in Global Law Making;
- Having passed the "Major Issues of Global Law" exam;
- Acquisition of at least 18 credits (CFU);
- Weighted average grade of at least 26,00/30.

The host University reserves the right to perform an additional evaluation of the applications and/or request additional documentation.
