Art. 1 – Object of the selection

1. A selection call is issued by the Faculty of Law at the University of Trento for the Academic Year 2026/2027 for **16 positions with scholarship** and for potential **additional positions without scholarship**, for a study period within the Double Title Program at one of the partner Universities listed in **Attachment 1**.
2. Attachment 1 to the present call includes an information sheet for each partner University indicating:
 - a) number of positions and scholarships available and their amount
 - b) degree courses involved;
 - c) the requirements at the time of application and, for selected students, at the time of the application to the partner university or before departure to the destination;
 - d) duration of the stay at the partner University and mobility period;
 - e) general information about the partner University and any further requirements requested by the partner.
3. The information contained in Attachment 1 may be subject to updates during the period the call is open, based on feedback from the partner institutions. Any updates will be published online on the "[Double Degree](#)" webpage and appropriately notified.
4. Applicants are required to choose their destination, with the possibility of indicating a maximum of 2 destinations. The order of preference is not binding for the purpose of destination assignment by the Commission.
5. Applicants who, at the date of publication of this call, have already been awarded another international mobility scholarship are not eligible to apply if the periods of the two mobilities overlap.

Art. 2 - Admission requirements

1. Except for the specific cases regulated in the subsequent paragraph 4, students of the Faculty of Law of the University of Trento who, **by the deadline of this Call**, meet the **requirements** indicated in Annex 1 and are in one of the following conditions, may participate in the selection:
 - a) being regularly enrolled in the master course in Global Law Making or in the 5-year master course in Law, as indicated in Attachment 1. In the case of simultaneous enrolment in two courses at UniTrento, it will only be possible to apply for one of the active careers. In the case of dual enrolment in another Italian or foreign university, it will be possible to apply at both calls, but it will not be possible to carry out two mobility programmes promoted by the two



- different universities in the same period, under penalty of cancellation of the mobility programme assigned by UniTrento;
- b) having the specific requirements for the destination(s) of interest as indicated in Attachment 1;
 - c) having knowledge of the English language equal to at least the level required for the destination(s) of interest, as indicated in Attachment 1 under the heading "Language Requirements for Application at UniTrento". **Knowledge of the English language at a level at least equal to that required by the destination is a mandatory requirement for admission to the selection process.**
2. To be admitted to the selection, candidates must prove their knowledge of the language required for that destination at least at the level indicated in Attachment 1, under the heading "Language Requirements for Application at UniTrento" according to one of the methods below:
- a) holding a language certificate among those listed on the [Language Center webpage](#)¹ section "2- Per l'ammissione ai corsi di studio, Mobilità Internazionale e accesso ai corsi CLA" (For admission to study courses, International Mobility and access to CLA courses) (the certificate must be uploaded in the online application);
 - b) holding one of the specific international certificates possibly required by the destination, as indicated in Attachment 1 "Language requirements for admission to the partner University" (attach the certification within the online application);
 - c) Being a native speaker in the required language² (this requisite has to be declared in the online application);
 - d) Having passed the English language exam testing the four abilities (reading, speaking, writing and listening) available in the candidates' UniTrento study plan if the language the level is at least the same as the one required by the partner University (this requisite has to be declared in the online application);
 - e) Having passed the English language exam testing the four abilities in another University, if the language level is at least the same as the one required by the partner University (upload appropriate documentation);

¹ Pay attention to the expiring date of the certificate and the minimum scores required for each language skill in the CLA tables.

² Mother-tongue speakers are citizens who, by linguistic experience, have the ability to express themselves naturally in their mother tongue. They will be asked to enclose with their application a self-certification stating that they have completed at least the entire course of primary and secondary education in the selected language.



- f) Holding a High School, Bachelor or Master's Degree diploma either awarded in a country where the official language is the same as the required one or taught in the required language (upload appropriate documentation³);
 - g) Having passed, no longer than 5 years ago, the Language Centre (CLA) four-abilities language test for a mobility call of the University of Trento⁴ in the previous years (this requisite has to be declared in the online application);
3. Candidates who are unable to attest to the possession of the linguistic requirement according to one of the methods listed above may request the inclusion of a maximum of two language exams (English, French, Spanish, German) in their study plan, in compliance with the Academic Regulation of their degree program. The request must be submitted by 12:00 PM (noon) on 17/12/2025 through the specific online application (apply) "[Request to add language tests to the study plan for 2026/2027 international mobility applications](#)". The exams must be taken during the standard sessions organized by the CLA and within the deadline of this call. For further information, please check the [Linguistic Requirement](#) webpage.

Art. 3 – Requirements for starting the mobility

- 1. Mobility periods financed with a scholarship must mandatorily conclude within the standard duration of the study course plus 1 year, i.e., by the maximum limit of the first year "fuori corso" (beyond the official duration). Participation in this call as a "fuori corso" student is only possible for the assignment of potential mobility positions without a scholarship.
- 2. At the time of departure for the study period abroad, the student must:
 - a. Be regularly enrolled in the 5-year Master's Degree in Law (Laurea a ciclo unico in Giurisprudenza) or the Master's Degree in Global Law Making for the A.Y. 2026-27, through the payment of university fees or the renewal of enrollment with a request for benefits from Opera Universitaria or UniTrento;
 - b. Possess, in relation to the assigned destination and within the deadlines indicated by the partner university, any further requirements specified in Attachment 1, "Academic Requirements for admission to the Partner University" and "Language Requirements for admission to the Partner University." It is the applicant's responsibility to verify the deadlines and procedures for submitting this documentation to the partner university,

which may be requested already during the data submission phase to the host university (application).

3. Within the scope of this call, each candidate may undertake only one mobility period.

Art. 4 – Application procedure

1. Applications have to be submitted **online only** at the link indicated at the University's webpage [Outgoing mobility](#). The application must be completed online **by January 26th 2026, at noon (CET)**. As confirmation of the correct and definitive submission of the application, the system automatically sends a summary email. Once submitted, the online application form cannot be modified, supplemented, or cancelled. In case of difficulties during the completion of the online application, applicants are advised to save the entered information and contact the offices at the addresses listed in Article 9 well in advance of the deadline.
2. Candidates may select a maximum of **2 destinations**. The order in which the preferences are expressed will be considered by the Selection Committee, but it will not be binding.
3. Candidates must upload the following documents for each chosen destination:
 - a) Study Project (one for each chosen destination) written in English as per Annex 2 of this call. The document must be uploaded to the dedicated section of the online application in one of the following formats: .pdf, .doc, .docx;
 - b) Curriculum Vitae et Studiorum written in English. The document must be uploaded to the dedicated section of the online application in one of the following formats: .pdf, .doc, .docx;
 - c) (if applicable) Certificate proving knowledge of the English language. The document must be uploaded to the dedicated section of the online application in one of the following formats: .pdf, .doc, .docx, .gif, .jpeg, .png;
 - d) (Optional) Any other qualifications deemed useful for the selection process. The document must be uploaded to the dedicated section of the online application in one of the following formats: .pdf, .doc, .docx, .gif, .jpeg, .png;
 - e) (Where applicable) Self-certification (listing the title of the exam taken, date of the exam, credits acquired, and the grade obtained if already available) relating to exams taken by the deadline of this call and not yet registered in ESSE3.

The certificate of enrollment in the Faculty of Law at the University of Trento, including exams taken, grades obtained, credits acquired, and the weighted average, will be acquired automatically by the office.



4. Candidates with special educational needs are invited to contact the offices in advance (using the contacts listed in Article 9) to request support in submitting the application and to identify appropriate assistance.
5. Pursuant to DPR No. 445/2000, the candidate may submit a self-declaration in lieu of certification (dichiarazione sostitutiva di certificazione) attesting to the possession of the qualifications and requirements referred to in paragraph 2), accompanied by a photocopy of a valid identity document. The Faculty of Law at the University of Trento reserves the right to request the original documentation after the publication of the results of the commission's work.

Art. 5 – Selection

1. The selection is based on qualifications and an interview.
2. Before the selection process, the following will be verified automatically by the office:
 - a. The completeness of the documentation attached to the regularly submitted online applications, with reference to the provisions of Art. 4 of this call;
 - b. The applicants' possession of the admission requirements set out in Art. 2 of this call.
3. Candidates who are found not to be in possession of the admission requirements referred to in Art. 2 will be excluded from the selection process.
4. Candidates found eligible following the verification of admission requirements will be evaluated by a Faculty Commission, appointed by Rectoral Decree.
5. The Commission's evaluation criteria are determined as follows:
 - a. Study Project: maximum 35 points out of 100
 - b. Interview and Curriculum Vitae: maximum 35 points out of 100
 - c. Weighted average of the grades of the exams taken by the deadline of this call: maximum 30 points out of 100.
6. Candidates found eligible following the verification of admission requirements will be summoned to attend an interview with the Commission (also via videoconference).
7. The list of candidates admitted to the interview before the Commission will be published on the University Portal on the [Double Degree](#) webpage with at least 3 days' notice prior to the actual date of the interview. Summoned candidates will simultaneously receive a notice of convocation sent to



their institutional email address. The candidate's absence from the interview will be considered as withdrawal from the selection, regardless of the cause.

8. Should the number of applications for a destination exceed 15, the Commission may decide to admit a maximum of 15 candidates for that destination to the interview, based on the evaluation of the study project and the weighted average of grades.
9. The Selection Committee can request the candidate to use the language required for the destination during the interview.
10. The Committee will draw up a ranking list for each destination based on the points scored by each candidate in each of the above-mentioned criteria.
11. The minimum score required is 70 points.
12. Even in case of successful completion of the selection process at the University of Trento, representatives of the partner University may request candidates to undergo a further interview and/or an assessment of the working knowledge of the English language, which may be conducted by telephone and/or via videoconference.
13. In case some scholarships are not assigned, they might be re-assigned to another destination by the Committee, if the partner University is willing to accept more students.

Art. 6 – Drawing up of the rankings and allocation of destination

1. The final ranking lists will be published on the University's [Double Degree](#) within 5 working days from the ending date of the interviews. Scholarships for each destination are awarded following the ranking list order.
2. The final rankings will be published anonymously, with reference only to the Application ID. The Application ID can be found in the confirmation email automatically sent by the system upon submission of the application, or in My Applications on MyUnitn.
3. Candidates will have to send, within the deadline mentioned in the email, a declaration of acceptance provided by email by the given deadline.
4. In case of withdrawal of a selected candidate, the next eligible candidate in the ranking list will be offered the place if the deadlines of the partner university allow that.
5. The Commission has the discretion to assign mobility places without a scholarship, proceeding according to the order of the ranking list. In case of withdrawal by the scholarship recipients, the funding will be assigned to eligible candidates without a scholarship, strictly following the order of the ranking list and absolute merit.



6. The allocation of the scholarship or the potential mobility position without a scholarship only becomes final after the acceptance of the selected student by the host University. This is because some partner Universities reserve the right to conduct further language tests or additional evaluations of the applications and/or request supplementary documentation and potentially reject the proposed application. Therefore, please consult the partner university's website well in advance, as indicated in Attachment 1.
7. Selected students who, for the same period of study abroad, have been assigned a mobility position within another international program, must submit a formal withdrawal from the previously accepted mobility before submitting the declaration of acceptance for this position.

Art. 7 – Activities abroad and mobility period

1. Candidates who participate in the Double Title programme have to remain regularly enrolled in the University of Trento for the whole duration of their mobility abroad.
2. The University of Trento guarantees, to those who undertake a mobility period abroad under this call, the recognition of the activities certified by the foreign Host Institution through the Transcript of Records (ToR) and previously indicated in the Learning Agreement (study plan abroad) and any amendments. It will not be possible to reject the grades of exams included in the Transcript of Records as successfully passed and previously listed in the Learning Agreement.
3. The actual duration of the mobility period will be attested by the partner university.
4. Participants are invited to:
 - a) check for security or risk alerts on the [website of the Italian Ministry of Foreign Affairs](#);
 - b) check carefully how the mobility will be carried out at the partner university in case of a pandemic or other circumstance of force majeure, with particular reference to online teaching, availability of services such as student housing, canteens, etc.;
 - c) buy a travel insurance covering for cancellations/delays due to pandemic or other force majeure circumstances;
 - d) buy a health insurance explicitly covering for costs related to hospitalization and treatments due to a pandemic/epidemic;
 - e) selected students must autonomously check if a visa is required for the country of destination and the relevant requirements to obtain it.

- f) In the case of possession of a residence permit or temporary protection, find out about the regulations in Italy and in the host country. If necessary, renew the documents in time for the start of the mobility;
- g) check the cost of living in the destination country and of the economic requirements necessary to obtain the visa, if applicable (proof of solvency).

Art. 8 – Scholarship payment and start of the mobility

1. The scholarship is awarded only upon the actual realization of physical mobility abroad and participation in study activities. The scholarship amount, indicated in the destination sheet, is paid in two instalments according to the following methods:

For the first two semesters of physical mobility:

- a) The first half of the annual amount within two months following the start of the mobility (attested by sending a specific certificate of attendance signed by the partner University);
- b) The second half of the annual amount within two months following the start of the second semester.

For the following semesters of physical mobility, if applicable:

- a) The first half of the annual amount within two months after the beginning of the third semester of mobility;
- b) The second half of the annual amount within two months after the beginning of the last semester of mobility.

2. Students with a 2026 University ISEE value⁵ equal to or less than €25,000.00 may receive an additional contribution of €1,250.00 per semester.
3. A one-time contribution is provided to support travel expenses, differentiated according to the destination country as follows:
 - a) Destinations in the UK: €500
 - b) Destinations in the USA: €1,500

No further contributions are provided by the University of Trento.

4. In case of withdrawal or interruption of the stay without just cause, the selected student will be required to return any scholarship funds received. This repayment constitutes a condition for admission to the final examination for the Single-Cycle Master's Degree/Master's Degree.

⁵The 2026 University ISEE value must be calculated by June 30, 2026, for departures in the first semester.



5. The scholarship is to be considered as a contribution towards the travel costs of the study period spent abroad. It is not meant to be a contribution towards tuition fees, if these are required by the partner universities. In case of a virtually carried out mobility, the scholarship will not be awarded. It does not entitle to any social security treatments nor evaluation towards juridical and economic careers, nor automatic recognition for social security objectives.

The scholarship is subject to taxation as foreseen by the law.

6. Candidates are advised to inquire beforehand about the cost of living in the destination country and, also for the purpose of visa issuance, about the financial guarantees required for the entire mobility period.
7. Students with special educational needs can benefit from the services offered by the UniTrento Inclusion Service and may submit a request for an additional financial contribution to the University of Trento. The additional financial contribution for students with special needs will be granted at the end of the mobility period on the basis of actual costs met abroad. In order to access these services, students have to contact the relevant International Mobility Office.
