



## Selection for admission to the FUTURA (Formazione Universitaria per Rifugiati/e e Richiedenti Asilo) project - Academic year 2026-27 (English translation)

### Art. 1. Objects and candidates

1. The University of Trento is selecting **five** students for the academic year 2026/27 willing to be admitted to the project FUTURA (Formazione Universitaria per Rifugiate/i e Richiedenti Asilo).
2. The five selected students will be initially enrolled in single courses. Enrolment in the Bachelor's, Single cycle Master's or Master's degree course of choice is subject to passing the admission test or meeting the necessary requirements (see Art. 2 (1)) by 5 August 2027.
3. The following can apply to the FUTURA project:
  - asylum-seekers; *or*
  - holders of refugee status; *or*
  - holders of subsidiary protection status; *or*
  - holders of special protection status.

who are on the Italian territory and have at least 12 years of schooling and a qualification permitting access to university higher education (see Art. 6 (2),(3)).

### Art. 2. Structure

1. The academic path is structured differently depending on the degree level of interest:

#### Bachelor's degree



Year of project	Minimum credits to be reached by 5 August
Foundation year a.y. 2026-2027	passing the admission test, if foreseen (by September 2027)
2nd year	35 ECTS by 5 August 2028
3rd year	75 ECTS by 5 August 2029
4th year	120 ECTS by 5 August 2030
(possible 5th year)	180 ECTS by 5 August 2031

## Master's degree

Year of project	Minimum credits to be reached by 5 August
Foundation year a.y. 2026-2027	obtaining admission requirements and passing admission tests, if any (by September 2027)
2nd year	35 ECTS by 5 August 2028
3rd year	75 ECTS by 5 August 2029
(possible 4th year)	120 ECTS by 5 August 2030

2. More specifically, the project phases are as follows:

- First preparatory year (**Foundation Year**) starting in a.y. 2026/27 including:
  - attendance of Italian language courses and language courses required by the study plan of the academic area of interest, provided by the University Language Centre;
  - attendance of courses to obtain computer skills;
  - attendance of preparatory courses in the academic area of interest, if provided for in the curriculum (such as crash courses);
  - attendance of single courses and taking exams in the academic area of interest that will be recognised in the study plan once enrolled in the Bachelor's/Master's course;
  - preparation for the admission test<sup>1</sup> and obtaining the necessary requirements to be admitted to the bachelor/master course of interest<sup>2</sup>.
- Three years for a Bachelor's degree and two years for a Master's degree, with relevant benefits and services (see Art. 3);
- A possible additional year to complete the course of study with relevant benefits and services (see Art. 3).

## Art. 3. Scholarship and economic support

1. The selected students will:

- be fee waived for the attendance of single courses;
- be fee waived for the attendance of the following courses offered by the University Language Centre (CLA):

- Italian up to the B2 level;
- English up to the level required by the course curriculum;

- be fee waived for the attendance of degree courses;
- have free board and lodging for the whole project duration;
- receive a scholarship from the University of Trento equal to 150 Euro per month, paid out every two months, for small personal expenses and the purchase of books.

## Art. 4. Enrolment renewal

1. Transition to the next year of the project with consequent renewal of the scholarship takes place if the requirements and university credits (ECTS) set out in Art.2(1) are satisfied by 5 August of each academic year.
2. In the event of non-renewal of the scholarship due to failure to achieve the required merit, the student(s) will nonetheless be fully exempt from registration and university fees for the following academic year only.

## Art. 5. Additional support measures

1. Selected applicants will be entitled to the following forms of additional support throughout the duration of the FUTURA project:
  - accommodation (Opera Universitaria di Trento)
  - jolly card for two free meals a day at university canteens (Opera Universitaria di Trento);
  - access to personal orientation services (UniTrento);
  - assignment of an academic tutor for guidance and mentoring during the university course (UniTrento);
  - psychological support (UniTrento e Centro Astalli Trento);
  - legal assistance (Centro Astalli Trento);
  - access to sports activities with UniTrento Sport (UniTrento);
  - possibility to carry out part-time, paid collaboration activities with the University of Trento (UniTrento);
  - annual ticket for urban and extra-urban transport in the Province of Trento (UniTrento);
  - a notebook on free loan (UniTrento);
  - welcome and integration activities in the local area (UniTrento and local organizations).

## Art. 6. Admission requirements and necessary documents

1. For the application to be considered eligible it is necessary that the applicant:
  - holds:
    - refugee status; *or*
    - subsidiary protection; *or*
    - special protection; *or*
    - temporary protection; *or*
    - residence permit for asylum-seekers;
  - lives in Italy;
  - has completed a study course which allows access to a Bachelor's degree or Master's degree course in Italy.
2. In particular, for access to a **Bachelor's degree**, it is necessary to submit:
  - a final secondary school diploma obtained after **at least 12 years of schooling** and allowing access to university studies in the educational system of the country in which the qualification was obtained;
  - list of subjects passed with relative grades of the 12th year of schooling (transcript of records);
  - any documentation proving that the necessary test to access university has been passed, if provided for in the education system of the country in which education was given;
  - residence permit;



- identity document (ID card or passport);
  - any language certifications, other academic or professional qualifications if held;
  - any comparability attestations already held (CIMEA or EQPR);
  - CV, if any.
3. In particular, for access to a **Master's degree**, it is necessary to submit:
- Bachelor's degree diploma that allows for the continuation of studies at Master's degree level in the country in which the degree was obtained.;
  - list of examinations taken (transcript of records);
  - residence permit;
  - identity document (ID card or passport);
  - any language certifications, other academic or professional qualifications if held;
  - any comparability attestations already held (CIMEA or EQPR);
  - CV, if any.
4. Should the candidate not be in possession of all or part of the documents<sup>3</sup> necessary to verify his/her previous studies, it is compulsory for him/her to complete the "Study history" document (to be found at the following link: <https://www.unitn.it/en/FUTURA>) and to attach it, in its entirety, to the online application. In this case, it is recommended that the document is filled out with the name in the original language of any qualifications obtained.
5. When finalizing enrolment in the study course of choice for the 2027/28 academic year, in addition to the documentation already requested at the application stage, the Certificate of Comparability and/or Verification issued by CIMEA may be requested<sup>4</sup>.

## Art. 7. Application procedure and deadlines

In order to be admitted to the selection candidates must submit their application through this link: [Formazione Universitaria per rifugiati/e e richiedenti asilo 2026/2027](#) by **30 March 2026 (12.00 PM)**.

## Art. 8. Selection process

1. The selection will take place in two phases:
  - Stage 1: From the applications received by the deadline and considered eligible, **a maximum number of 10 candidates** will be selected and admitted for a selection interview;
  - Stage 2: Following the interview, a shortlist will be drawn up and the **first five candidates** will be declared admitted to the project.
2. In the event that at least one of the students admitted for interview fails to attend on the pre-established date and time, the University of Trento reserves the right to re-select the same number of eligible candidates as those who failed to arrive and to schedule a second interview with the reselected candidates.

## Art. 9. Ranking and available places assignment

1. The outcome of the selection procedure will be published on the University of Trento website at <https://www.unitn.it/en/FUTURA> and will be notified to the candidates admitted to the project by email to the address they provided during the application process.
2. Should one or more of the admitted candidates withdraw from the project or should they not start the

<sup>4</sup> The Statement of Comparability is issued by CIMEA free of charge to students with a residence permit for international protection. In case of successful students holding a residence permit as asylum-seekers, whose procedure has not yet been completed by the territorial commissions when enrolling in the a.y. 2027/28, the University of Trento can decide to cover the costs for the issuance of the Statement of Comparability.



university course by 30 September 2026, the University reserves the right to re-rank one or more additional candidates and award them the scholarship.

## Art. 10. Confirmation and enrollment

Selected candidates must confirm their acceptance of a place in the project in the modalities indicated in the notification of assignment and within the deadline specified in the relevant email communication.
